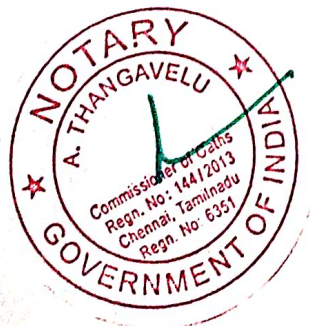
2. That the School started in the year 2021, in the name and style of "MAHARISHI

12. That the school will ensure that all required infrastructure is available with the school before starting classes


13. That the school will ensure that sufficient number of qualified teachers as per the provisions contained in affiliation – bye laws are available with the school before starting classes.

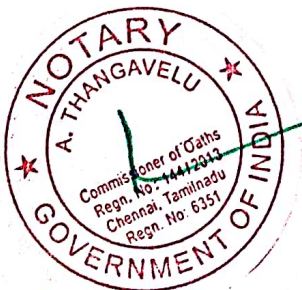


